2. The above fee structure is valid as on Oct. 01, 2010 and is subject to revision at any time at the sole discretion of the Management.
3. Fees for Categories coded EE, EW & FB are payable in US Dollars.
4. The interest-free security deposit will be refundable at the expiry of the membership tenure.
5. Foreign Currency payments will be governed by RBI rules prevailing as on date of receipt of these payments.
6. In the case of NRIs the interest-free security deposit is receivable in foreign exchange but will be converted into Indian Rupees immediately on receipt thereof and the amount to be refunded on the expiry of his term, or earlier, will be the actual amount so converted and received from the client, as reduced by debits against it, and paid back in Indian Rupees subject to the law governing payments to Non-Residents.
7. EW & Mid-Week category members will be eligible to play only on weekdays only. They cannot use the course on weekends, or public holidays. They are, however eligible to use all other facilities throughout the week.
8. The management shall have the absolute right and sole discretion to add or amend the membership fee structure from time to time and all such additions and amendments will be notified by displaying them only on the Notice Board of the club and shall become immediately binding on all users of the club.
